

THIS TELECOMMUNICATIONS LICENSE AMENDMENT AGREEMENT dated the 28th day of June, 2010.

BETWEEN:

265 CARLING AVENUE LTD.

(the "Licensor")

OF THE FIRST PART

AND:

ATRIA NETWORKS LP

(the "Licensee")

OF THE SECOND PART

WHEREAS by a telecommunications license agreement dated the 2nd day of August, 2005, (the "License") the Licensor licensed to Telecom Ottawa Limited for and during a term of 5 years expiring on the 31st day of July, 2010, the use of certain premises as more particularly described in the License, located at **265 Carling Avenue**, in the City of Ottawa, Province of Ontario;

AND WHEREAS on March 20, 2008, further to the sale of all of the issued and outstanding shares of Telecom Ottawa Limited to the Licensee, the Licensor consented to the assignment of the License to the Licensee;

AND WHEREAS pursuant to Section 14 of the License, the Licensee has two (2) options to extend the License for further periods of five (5) years;

AND WHEREAS the parties hereto desire to amend certain provisions of the License.

NOW THEREFORE in consideration of the premises and the mutual covenants herein contained, the Licensor and the Licensee hereby agree as follows:

1. **Term.** The effective commencement date of the extension is August 1, 2010 expiring on July 31, 2015 unless otherwise terminated or extended pursuant to the terms of the License.
2. **Extension of Term.** The parties acknowledge that the Licensee has the option to extend the Term of the License for one further period of five (5) years upon at least six (6) months notice to the Licensor.

3. **License.** Except as set out in this Agreement, the Licensor and the Licensee agree that all other terms and conditions of the License, as amended, shall remain unamended and in full force and effect.
4. **Enurement.** This Agreement shall be binding upon and enure to the benefit of the parties hereto and their respective successors and permitted assigns.


