


**INFORMATION PAGE**

This page sets out information which is referred to and forms part of the TELECOMMUNICATIONS LICENSE AGREEMENT made as of the 16th day of March, 2008 between bcIMC Realty Corporation as Licensor and ATRIA NETWORKS LP., as Licensee. Defined terms in this Information Page have the same meaning as in the Telecommunications License Agreement. The information is as follows:

**Building:** the office buildings municipally known as **105 Hotel de Ville Road** in the City of Gatineau, and the Province of Quebec.

**Commencement Date:** the 1st day of April, 2008

**Equipment Room:** approximately 50 Square Feet.



**License Fee:** the annual sum of One Thousand Two Hundred and Fifty dollars (\$1,250.00) payable annually in advance on the Commencement Date and the anniversary of the Commencement Date thereafter. ~~The License Fee shall increase annually on the anniversary of the commencement date by the greater of CPI or three per cent (3%).~~

**Electricity Charges:** Subject to Section 6 herein, the electricity charges shall be \$0.00. The Licensee does not have any active equipment in the building as of the Commencement Date.
