

THIS TELECOMMUNICATIONS LICENSE AMENDMENT AGREEMENT dated the 2nd day of November, 2011.

BETWEEN:

234 LAURIER LEASEHOLDS LIMITED

(the "Licensor")

OF THE FIRST PART

AND:

ROGERS COMMUNICATIONS PARTNERSHIP

(the "Licensee")

OF THE SECOND PART

WHEREAS by a telecommunications license agreement dated the 29th day of November, 2006, (the "License") the Licensor licensed to Atria Networks LP (formerly Telecom Ottawa Limited), a subsidiary of Rogers Communications Partnership, for and during a term of 5 years expiring on the 30th day of November, 2011, the use of certain premises as more particularly described in the License, located at **234 Laurier Avenue West**, in the City of Ottawa, Province of Ontario;

AND WHEREAS on September 1, 2011, Atria Networks LP was wound-up into Rogers Communications Partnership;

AND WHEREAS the parties wish to extend the term of the License;

AND WHEREAS it is in the best interests of the parties to amend the terms of the License;


NOW THEREFORE in consideration of the premises and the mutual covenants herein contained, the Licensor and the Licensee hereby agree as follows:

1. **Licensee.** The name of the Licensee is Rogers Communications Partnership.
2. **Term.** The effective commencement date of the extension is December 1, 2011 expiring on November 30, 2016 unless otherwise terminated or extended pursuant to the terms of the License.

3. **License Fee.** The Licensee shall pay to the Licensor during the term of the extension an annual License Fee in the amount of one thousand two hundred dollars (\$1,200) per year, plus HST.
4. **License.** Except as set out in this Agreement, the Licensor and the Licensee agree that all other terms and conditions of the License, as amended, shall remain unamended and in full force and effect.
5. **Enurement.** This Agreement shall be binding upon and enure to the benefit of the parties hereto and their respective successors and permitted assigns.
