

THIS TELECOMMUNICATIONS LICENSE AMENDMENT AGREEMENT dated the *15th* day of *April*, 2010.

BETWEEN:

BELEMARE BROS. REALTY

(the "Licensor")

OF THE FIRST PART

AND:

ATRIA NETWORKS LP

(the "Licensee")

OF THE SECOND PART

WHEREAS by a telecommunications license agreement dated the 10th day of October, 2006, (the "License") the Licensor licensed to Telecom Ottawa Limited for and during a term of 42 months expiring on the 30th day of April 2010, the use of certain premises as more particularly described in the License, located at **1427 Ogilvie Road**, in the City of Ottawa, Province of Ontario;

AND WHEREAS in May of 2008, of all of the issued and outstanding shares of Telecom Ottawa Limited were sold to the Licensee;

AND WHEREAS pursuant to Section 13 of the License, the Licensee has two (2) options to extend the License for a period of five (5) years each;

AND WHEREAS the parties hereto desire to amend certain provisions of the License.

NOW THEREFORE in consideration of the premises and the mutual covenants herein contained, the Licensor and the Licensee hereby agree as follows:


1. **Licensee.** The name of the Licensee is changed to Atria Networks LP (formerly Telecom Ottawa Limited).
2. **Term.** The effective commencement date of the extension is May 1, 2010 expiring on April 30, 2015 unless otherwise terminated or extended pursuant to the terms of the License.

3. **Extension of Term.** The parties acknowledge that the Licensee has the option to extend the Term of the License for one further period of five (5) years upon at least three (3) months notice to the Licensor.
4. **License.** Except as set out in this Agreement, the Licensor and the Licensee agree that all other terms and conditions of the License, as amended, shall remain unamended and in full force and effect.
5. **Enurement.** This Agreement shall be binding upon and enure to the benefit of the parties hereto and their respective successors and permitted assigns.

IN WITNESS WHEREOF, the parties have executed this Agreement by the hands of their respective officers duly authorized in that behalf as of the date first set forth above.


